

MHCT HUNTING RESERVATION AND CONTRACT

Services:

All hunts include meals, lodging, and transportation in the field during the hunt, game retrieval, skinning of game, and delivery of game to a meat processing plant and are guided two hunters per guide unless otherwise stated in the Montana High Country Tours, Inc. (MHCT) hunting brochure. All State hunting licenses and permits, taxidermy, gratuities, meat processing and airport shuttle service is not included unless otherwise stated in the brochure. Absolutely no drugs or excessive use of alcohol is allowed.

Booking Terms:

All reservations are subject to approval and must be accompanied by the required 1/3 deposit. The balance is due and payable by September 1st, for all Big Game Hunts. No rate reduction can be made if hunter fails to arrive on prearranged date, or leaves before the end of contract period. Every effort will be made to schedule your hunt on the dates you have chosen; however, MHCT reserves the right to adjust that schedule. Schedule adjustments may occur from but are not limited to: MFWP change of season dates, public land closure due to fires, etc., failure of hunter to pay balance of hunt fee by due date or hunter needing to be partnered with another hunter to receive a two hunter per guide hunt. Prices are subject to change due to fluctuating fuel & energy price, insurance rates and fees just to name a few.

Licensing Policy:

Elk – Deer licenses are guaranteed to “outfitter sponsored” clients. Upon MHCT receipt of your hunting reservation and contract, including your deposit, MHCT will provide you with an outfitter certificate that entitles you to receive one of the guaranteed “outfitter sponsored” licenses. Elk – Deer licenses sell on March 15th of each year, all paperwork must be completed and returned to the Montana Fish Wildlife & Parks by March 15th.

Special Permits:

Applications for moose, big horn sheep and mountain goat must be postmarked by May 1st. Applications for antelope, cow elk and deer B must be postmarked by June 1st. A random drawing takes place for special permits; no preference is given to outfitter’s clients.

Refund Policy:

Elk – Deer Hunt – No refunds since elk – deer licenses are guaranteed to outfitter sponsored clients. No refund if client’s application for license is returned or revoked by the Montana Fish Wildlife & Parks due to applicant’s error or if it is not received by March 15th. All Other Big Game Hunts – Seventy five percent of the deposits will be refunded if hunter is unsuccessful in obtaining a license in this drawing or 100% of the deposit will be credited toward next year’s hunt.

Cancellation Policy:

It is nearly impossible to fill openings created by cancellations. Refunds, less a 25% cancellation fee, will only be made if another hunter fills your hunt. You will be responsible for any balance owed to MHCT, as per this contract. You may want to consider cancellation insurance. Liability/Photo Release:

Hunting is a strenuous activity requiring stamina and good conditioning and the use of weapons such as firearms and bows, which can produce injury. The hunter recognizes all risks, which can arise during hunting and holds harmless, forgives and releases and waives any claims, which he/she may have with MHCT. From time to time in our modern society, disputes arise and the hunter agrees that Montana law shall govern this contract and the legal obligations of MHCT. The hunter also agrees that the district court of Beaverhead County, Montana shall be the exclusive and sole venue for all suits that may arise out of any disputes concerning this contract and the services provided by MHCT. In the event a suit is filed, the prevailing party shall be entitled to attorney fees. MHCT will use its best knowledge, expertise and efforts to provide outfitter/guide services to the best of their ability. MHCT does not guarantee conditions beyond its control such as weather, interference from other hunters, availability of game, etc. and the hunter accepts these terms. Hunter authorizes MHCT to use any photos of him/her and any game animal that he/she harvests for promotional purposes.

Participant agreement – Acknowledgement of Risk – Release:

I certify that I am capable of participating in this activity. I assume full responsibility for myself, for bodily injury, death and loss of personal property and expenses thereof, as a result of my participation. I agree to abide by all Montana game and trespass laws, and understand that my violation of such are grounds for MHCT to terminate this contract without refund. I have read, understand and by voluntarily signing this document accept the terms and conditions stated herein and acknowledge that this agreement shall be effective and binding upon me during the entire period of participation in the activity.
